IT IS ORDERED THAT :

1. The Claimants be given permission to amend the Particulars of Claim in the form of the draft dated 27th April 2018;

2. There be an injunction against the Second and Seventh Defendants in the terms of the separate Injunction Order of today's date appended hereto;
3. The claim for an interim injunction against the Fourth Defendant be refused;
4. The First and Second Defendants to pay the Claimants' costs of this application to be subject to detailed assessment if not agreed. The First and Second Defendant may make application within 14 days to seek to vary or discharge this costs order;
5. In the event of no defence being entered by the Second or Seventh Defendant by 14th May 2018, the injunction above will become permanently binding on that Defendant;
6. In the event that a defence is issued by a Defendant by 14th May 2018, the injunction will remain in place against that Defendant until trial or further order
